

# WibuBox/U+

### **Description**

The WIBU-BOX/U+ is the WibuKey protection hardware for connection to the USB interface of PCs, Apple Macintosh and others. Encryption works with WibuKey algorithm 1, 2 or 4 depending on up to 10 nonvolatile stored Standard Entries or Master entries. The first 5 entries may have an additional entry – data, expiration date or limit counter – which then occupies one entry. The WibuBox/U+ has an additional 16 kbyte memory.

The communication is according to USB specifications. All data communication is realized by endpoint 0 control transfers with full speed (12 MBit). The USB interface guarantees trouble free communication even if many different devices are connected and easy implementation to any system. WibuKey driver software supports all major operating systems, i.e.Windows, macOS and Linux distributions supporting USB. The WIBU-BOX/U+needs WibuKey Runtime 4.10 or higher.
